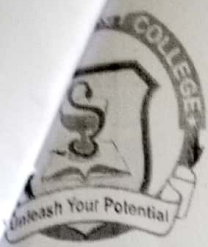

Item No. 4

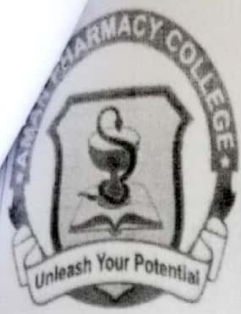
Ms. Afsana Bano, a member, recommends motivating the students to create posters that prohibit harassment of women.
