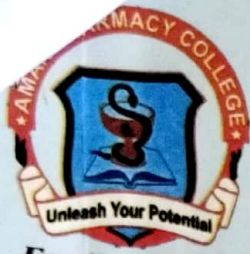

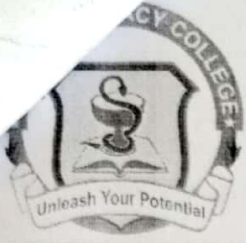
4. To enhance specific facilities for women on campus in terms of Safety and security, Counselling, Common Rooms, Day care center for young children (if possible).

Dr. Shruti Upadhyay suggests to organize gender sensitization workshop for the betterment of the organization.

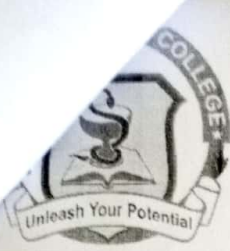
Ms. Afsana Bano suggests implementing of gender-neutral facilities and gender-based discrimination within the campus.

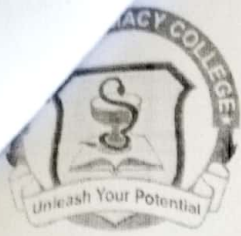
